About the Courses

Industrial and Construction Site Safety (2 hrs)

2 CEU Credits: SAF-13(2)-C026

This section will review the proper procedures and practices to ensure a safe working environment for workmen in an industrial setting. The participant will receive instruction on proper industrial work safety.

The NJ Uniform Construction Code (2 hrs)

2 CEU Credits: L/C-13(2)-C027

This section will introduce the participant to the permit and inspection requirements contained in the NJ Uniform Construction Code. Subjects will include: permitting, licensing, certificates, and the referenced standards. The participant will be familiar with the various rules that regulate installation of fire alarm and security systems. In addition, participants will also learn the process they need to follow to ensure a legal and properly installed system.

Understanding the NJ Barrier Free Subcode and Understanding the Americans with Disabilities Act (2 hrs each)

4 CEU Credits: L/C-13(2)-C029 and L/C-13(2)-C028

This section will review the requirements of the NJ Barrier Free Subcode (NJAC 5:23-7) and the Americans with Disabilities Act Code (36 CFT §1191), as they apply to both construction projects and the installation of alarm systems. The participant will understand the code requirements and options as they apply to building and fire systems. Various visualization and/or audible sensing alarm components available to disabled individuals will be reviewed.

ALL of these courses are REQUIRED for licensing AND renewal.

CEU Requirements for Burglar and Fire Alarm Licensing

Renewal (24 credits per triennial):

Each licensee shall obtain 10 continuing education credits in each triennial registration period in the following:

- 2 credits in the Barrier Free Subcode, N.J.A.C. 5:23-7;
- 2 credits in the New Jersey Uniform Construction Code, N.J.A.C. 5:23, exclusive of the Barrier Free Subcode;
- 2 credits in the Americans with Disabilities Act Code, 36 CFR 1191;
- 2 credits in industrial safety; and
- 2 credits in New Jersey law and rules governing the provision of burglar alarm, fire alarm, and locksmithing services.

In addition to the 10 continuing education credits

set forth above, each licensee shall complete the following, as appropriate:

1. If a licensee holds **one** Committee-issued license, he or she shall complete **14 credits** in courses relevant to the scope of practice of the license held, for a total of 24 credits. If a licensee holds a burglar alarm license, **3 of the 14 credits shall be in courses that concern smoke detection systems.**
2. If a licensee holds **two** Committee-issued licenses, he or she shall complete **14 credits** for each license held, in courses relevant to the scope of practice for each license, for a total of 38 credits. If a licensee holds a burglar alarm license, **3 of the 14 credits for that license shall be in courses that concern smoke detection systems.**
